SCHEDULE PUBLIC HEARING FOR A LOCAL LAW AMENDING CHAPTER 79 OF THE VILLAGE OF MONTGOMERY CODE ENTITLED "OUTDOOR DINING, SEASONAL," TO REMOVE THE PROHIBITION AGAINST ALCOHOL SALES AND CONSUMPTION FOR SEASONAL OUTDOOR DINING.

Moved by Trustee Picarello, seconded by Deputy Mayor Andolsek, the Board motioned to schedule a public hearing for May 7, 2024, at 7:30pm, for a Local Law Amending Chapter 79 of the Village of Montgomery Code entitled "Outdoor Dining, Seasonal," to remove the prohibition against alcohol sales and consumption for seasonal outdoor dining. Motion carried 4-Ayes, 0-Nays.

HYDRANT FLUSHING IN SPRING MEADOWS CONDOMINUMS
